## **PlanCheck**

PlanCheck is a web based solution that enables Local Authorities to carry out their plan-checking tasks online within DataSpace Live, our online system used by authorities to accept, process and approve applications.

Authorities can assess and comment on plans against a comprehensive 'Check' List. As they work their way through the list they can assign statuses, report outstanding conditions and even add comments to each check.


At any time the authority can use a 'Notify' button to send an automated email or text message of any outstanding conditions that require attention to the applicant or agent. The applicant or agent can then login to their Submit-a-Plan account to respond with a comment or upload any documents as required.

PlanCheck is another step in our goal to move all building control tasks online into DSLive to improve efficiency. With DSLive accessible from any location with internet access, PlanCheck is also a great solution to the increasing need of authorities to have employees working from home or to externalize their plan and structural checking activities to outside providers while still preserving the confidentiality of sensitive application or document information.

# **The PlanCheck Tab**

Each online application in DSLive will have its own 'PlanCheck' tab with a check-list of checks to work through.

Under the PlanCheck tab are tools for creating a check-list, changing a check's status, adding comments and notifying the applicant and agent of outstanding issues.





# The 'Check'-List

Authorities can create their own checks, check-lists and standard responses to use in PlanCheck.

Once setup templates of regularly used check-lists can be saved or unique check-lists can be created.

Your checks and templates can be then be managed and edited in our User Admin Tool.

managing your standard response in the admin tool


# **Status, Comments & Activity**


#### **Changing a Check's Status**

As an authority works their way through the check-list coloured flags and statuses can be assigned to represent whether a check has been approved or has outstanding issues. To those with a status of 'outstanding issues' the authority can add comments and requests for further documents and information.

#### **Comments & Activity**

Comments can be added to particular checks or as general comments. Comments can then be viewed by clicking on a check or under the 'notes' tab and can either be made visible to the applicant or agent or private. All activity carried out by the plan-checker and the applicant or agent is recorded under the 'activity' tab.






# Notifying the applicant or agent


#### **Notifying about Information Outstanding**

You may reach a check in your check-list where the information you have is not satisfactory. Once the status of a check has been changed to 'Information Outstanding' a comment can be added requesting more details or documents from the applicant or agent. DSLive will send the applicant or agent an email or text message alert.

#### The Applicant or Agent's Response

Once they receive their alert the applicant or agent can login to their Submit-a-Plan account to view the details and comments. They are provided with the tools to upload documents and send a response comment. The document and comments the applicant/agent add will appear against the relevant check as well as under the 'Documents', 'Notes' and 'Activity' tabs.
